NOTICE TO ALL FOWL HUNTERS

There will be a drawing for the rental of eight (8) waterfowl blind sites at Holden City Lake located approximately five (5) miles northwest of Holden.

Please use checks or money orders

Make checks payable to the City of Holden

- **Interested hunters may register now at: Holden City Hall – 101 W 3rd St Holden, MO 64040**
- **There must be a check or money order for \$300 included with the application. The \$300 application fee includes City Lake entry permits for your group. If your group is drawn, a blind deposit of \$100 (check or money order) will be required at the time of the drawing.**
- **The application fee and application must be submitted by 4:00 P.M. Monday, October 3rd, 2022. The drawing will be held October 4th at 6:00 p.m. at Holden City Hall, 101 West 3rd Street, Holden, MO 64040**

DRAWING PROCEDURES

1. **Blind #8 will be reserved for Camp Valor Outdoors**
2. **Drawings will alternate starting with Holden residents as follows:**
 - A. **Three (3) City of Holden residents**
 - B. **Two (2) residents outside city limits with a Holden address**
 - C. **Two (2) Johnson County residents**

RULES:

1. A fowl blind permit may be obtained by at least two (2) but not more than ten (10) persons joining together and making the application that shall then be randomly selected. Such blind permits may contain of up ten (10) names of persons eligible to use the blind. Adding names to the application after the application deadline will not be permitted.
2. Applicants must be present at the drawing. Those randomly selected for a blind will be able to select the blind of their choice in the order of selection. Photo ID will be required.
3. The fee for a fowl blind will be three hundred dollars (\$300.00) in addition to a hundred dollar (\$100.00) blind deposit. This deposit will be forfeited to the City of Holden if the blind is not removed by March 31st. Recipient must report when the blind is removed.
4. The waterfowl blind permit shall authorize the persons to whom it was issued to erect one waterfowl blind for the upcoming waterfowl season at the location designated by the City of Holden. No blind location marker shall be removed, defaced, or destroyed.
5. Hunters will be responsible for building and removing their own blinds.
6. No person shall hunt out of any waterfowl blind unless their name is on the application form or a guest of a member on the application and have a Lake Permit (***a member must be present with the guest***)
7. Any blind left on Holden City Lake property after March 31st will become the property of the City of Holden and will be removed and disposed of. No deposit will be refunded and hunters shall not be allowed hunting privileges for the next year.
8. Individuals may have their name on **ONE** blind application only. They may **NOT** apply for a blind site with more than one group.
9. During the waterfowl hunting season, all hunting-related accessories such as decoys, shell hulls and trash are the sole responsibility of the waterfowl hunter.
10. Steel Shot only.
11. Hunters must abide by all rules of this ordinance and rules and regulations of the Federal and State governments.
12. For the convenience of hunters, the City's prohibited off-road travel rule will be amended to allow "one time in and one time out" for placement and removal of blinds. Any wheel ruts or other evidence of placing or removing blinds must be repaired immediately by hunters.
